**AGREE**

**ONE.** - RTVE authorises interested research groups, regardless of whether they have taken part in the challenge organised by the Chair, to use the material released for the IBERSPEECH-RTVE Challenge 2018 in accordance with the provisions of this agreement.

All materials shall remain the property of RTVE. The transfer is made free of charge.

**TWO.** - The authorisation is solely and exclusively for any of the following purposes:

-Scientific articles.

-Research work (thesis, undergraduate dissertation, master's degree dissertation, etc.).

- Demonstrations in a strictly academic field.
- Conferences, congresses, seminars, etc., including those streamed live or made available after the event via websites or on social media.
- Teaching activity

The rights transfer shall be made solely for this purpose, on a non-exclusive basis, without the licensees being entitled to use the audiovisual and text material in any way not provided for in this agreement, nor to sell or in any way assign or encumber it.

The licensee acknowledges the confidentiality of the audiovisual and text material provided by RTVE, and may not make partial or full copies of it or allow any third party to make any copies of it.

**THREE.** - In any of these cases, the research groups or individual researchers who benefit from use of the data must include a text with the following acknowledgement in every public presentation:

*"This work uses data from RTVE 2018Database. This set of data has been provided by RTVE Corporation to help develop Spanish-language speech technologies."*

In the case of scientific publications, the authors must also mention, apart from the aforementioned acknowledgement:

**FOUR.** - The authorisation will be valid for three years from the date of public communication once the authorisation has been granted. If necessary, an extension may be requested for the same purpose once this period has elapsed.

**FIVE.** - RTVE will have access to the materials provided, and may, at its sole discretion, revoke all or part of the licensed materials, whether for editorial, legal or any other reasons. In this case, the licensee will cease using the materials and remove them from its databases.

**SIX.** - Personal data will be processed by RTVE Corporation in order to manage and maintain the contractual relationship. The legal basis that legitimises such processing is the execution of this licence. Your data will be kept for the time established in applicable legislation and will not be transferred to third parties unless legally mandated.

5. Breach of the law or the regulations set out in this agreement.

**EIGHT.**- Any dispute resulting from the interpretation or performance of this agreement shall be submitted to the Courts and Tribunals of Madrid.

**NINE.** - Applications must be sent by post to RTVE Documentary Archive Department, indicating the user, the purpose of the research and the period of use.
